WHAT ELSE SHOULD YOU KNOW?

The Victorian catastrophe enhances AFA member's frustration that the nation's worst natural disaster continues to highlight the debate about to burn or not to burn our National Parks, wilderness & nature reserve areas. Again we will read about yet another Colonial Coroner Inquiry. Again there will be millions of tax payers dollars spent on endless advice sought from "experts", reams & reams of paper used to publish recommendations. It is a travesty of justice that colonial enquires get caught up with the meaning of what a word means. The energy put into the definition of what a word means eg "cause" or "origin" by the coroner only blurs courts & government boundaries of responsibility.


Again, public confidence in the ability of coroners to dispense justice in a fair & impartial manner is largely dependent upon continuing recognition of the coroner's independence. The bias of a coroner should be avoided by knowledgment of all affiliations the coroner may have connected to the investigation; this includes private memberships of organizations that may have influence over decision makers.

Browsing through the AFA link to the previous Victorian & ACT bushfire enquiries and the Conneil of Australian Governments (COAG) recommendations, nothing except for the easier recommendations have changed. All suggest that the responsibility be shared between communities & fire

agencies, all recommend backburns so fuel load management will minimize risk of firestorms, all recommend research into indigenous traditional burning practices yet none have taken on the responsibility of leadership to unitate more aggressive back burning of our National Parks in their Fire Management Plans.

Research into back burning has been going on for longer than any research project most of us are aware of! Unfortunately the research into the long term impacts of firestorms on people & their community will identify the lasting legacy of our authority's inability to take leadership, make hard decisions, act decisively & control organizations that simply do not want the responsibility that goes with their mandate of forbidding access to our vast areas of bush.
